
# **Financial Statement**


Tuition is paid by the State and local jurisdictions, but these funds do not cover the supplemental programs our students often require to succeed in school. Financial support from the community enables The Foundation Schools to introduce creative approaches to pursue our mission to prepare our students to be productive and successful in their future academic and career paths.


Our continuing challenge has been to meet the intensive educational, clinical and behavioral needs of our students. With 82 percent of our student population in the poverty range, the need for outreach services linking students and families to available resources has increased dramatically.

88 percent of revenue is spent providing programs and direct services for our students. According to the American Institute of Philanthropy, most highly effective charities spend 75 percent or more on programs. The Foundation Schools has been awarded the Independent Charities Seal of Excellence for meeting the highest standards of public accountability and program and cost effectiveness.









# Congratulations to Our 2015 Graduates

he Foundation Schools is proud to honor 19 triumphant seniors of the graduating class of 2015! The students who walked across the stage to receive their diplomas carried with them an individual journey of trials and tribulations, challenges and frustrations. While their emotional disabilities presented them with behavioral/academic difficulties, they were able to succeed in reaching an important milestone—graduation from high school. With the support of the school staff, along with their family and friends, our graduates reached a milestone that, for some, is a first in their family.

The Foundation School of Montgomery County graduated three seniors on June 18, 2015. To congratulate these students on their achievements, the commencement address was given by former program therapist Siobhan Robinson, LCSW-C. Her uplifting speech highlighted the continued success our seniors can attain beyond our walls: "Make a life that shows the greatness that is you." The graduation remarks were presented by senior Christina R., who reflected on her experience with the school and her journey towards a remarkable milestone.

"Coming to the Foundation School gave me the new start I needed and I was ready. Things just seemed to keep getting better. Where I previously had negative school experiences, at The Foundation School, I was connecting with people that would eventually change my life and my attitude about my education. With the guidance and support I received, I finally felt that I could have a productive, fruitful future if I kept working and kept the commitment I made to myself to get to this stage. Even though I liked the school, many days my behaviors got the best of me, but the staff saw me through and they did not give up on me, even on my worst days."

The next day, The Foundation School of Prince George's County celebrated the graduation of 16 seniors. With a roar of applause for each graduate, the level of support and happiness in the room was palpable. Valedictorian Shakia P. presented a moving speech concluding with an unforgettable piece of advice for her peers:

"I know the people sitting here today and those that support you feel the same way about you, class of 2015. They believe in us. Let's make them proud and give our lives everything that we have to give, because you never know what good things may come out of them."

The ceremony showcased a choral performance of Katy Perry's "Roar" and emotional senior reflections delivered by program therapists. The commencement address was given by Carolyn Boston, Vice Chair, District 6, Prince George's County Board of Education. We are grateful for her participation and support.

Luke J. came to The Foundation School of Montgomery County (FSMC) in 2014 with attendance issues. His truant behavior was the product of

anxiety, a poor sleep routine and placement in programs that did not meet his needs or accommodate his disability—so much so that Luke was homeschooled before enrolling at FSMC.

We are proud to report that after a year with us, Luke's attendance, behavior and grades have greatly improved. "I have been going to school more often. The instruction here at FSMC is different than the public school that didn't have the right tools," says Luke.

Through individualized therapy, academic modification and staff support, Luke's classroom behavior is constantly improving. Beyond his gains in attendance, Luke's behavior and social skills have been enhanced, and he has grown into a helpful peer and leader. Without FSMC, he states, "I would not be going to school." Luke hopes to continue on his upward mobility by pursuing his dreams of becoming a computer programmer after high school.

Tiera I. arrived at The Foundation School of Montgomery County (FSMC) in 2007 after her previous school was unable to meet her behavioral and

emotional needs. As her erratic behaviors escalated, it was evident that Tiera required the critical individualized support and therapy provided by our schools.

The trust she established with staff bolstered her confidence to reach out for help when she was experiencing personal or academic challenges. Her initial difficulty communicating and socializing improved and she became an active participant in the school's cooking group. Subsequently, Tiera discovered her independence and identified her true passions, leading her to an internship at the Sunflower Bakery.

Tiera graduated from FSMC in 2015 with honors and whas continued to work with her job coach at the Family Service Agency to hone her interviewing skills and pursue her career dreams. When reflecting on her experiences and accomplishments at FSMC Tiera states, "FSMC helped me accomplish my goal to graduate high school."

# PARENT'S PERSPECTIVE

Like most parents, Ms. Felecia Taylor always wanted her son David to reach his full potential and succeed; however,

the academic and therapeutic support that David required was not available at the public school he was attending. After doing her research and hearing good things about The Foundation Schools (TFS) she knew, "In order for David to be successful, this is what we needed to do."

Ms. Taylor describes David's initial behavior as combative, stubborn and distrustful. Slowly, she witnessed his challenging behavior transform and he began to display the potential she knew he had. Ms. Taylor attributes David's behavioral improvements to the school therapists, stating, "The exceptional counselors would hold him accountable for his actions and encourage him to improve." She was especially impressed with the specialized attention staff provides to students and parents, stating, "Parents could be a part of the team, and not just sit on the sidelines." When asked if Ms. Taylor would recommend TFS to other parents, she had this to say, "I highly recommend The Foundation Schools. Talking from experience, we received the best. There was no question that went unanswered by the exceptional staff."

David has continued to make his mother proud as a thriving college student! Through the overwhelming support of his family, TFS staff and peers, David pushed himself to achieve something he never imagined—multiple college acceptances. We are so proud to be a part of David's success, and cannot wait to see all of the places he can go!


